A motion was made by Kyle Thompson and seconded by Bear Brown to approve the 2021-2022 T-TESS Calendar and Appraisers. The motion carried 5:0.

A motion was made by Kyle Thompson and seconded by Bear Brown to approve the Board Resolution regarding Extension of Employee Leave Benefits. The motion carried 5:0.

A motion was made by Casey Jordan and seconded by Kyle Thompson to the approve vote for TASB Board Representative Dr. Ben Donald. The motion carried 5:0.
